Ganta YMCA Precinct

At Ganta YMCA precinct, District No. 1 Senator Jeremiah Kpan Koung, Vice Presidential Candidate of the UNITY Party during his arrival of voting at that precinct, he and his entire security including other supporters who were not registered at that precinct demanded for their forceful voting which was granted by the presiding officers. A specific case of two of our poll watchers at said precinct namely, Raymond McCrity and Rufus Yarkpawolo were severely flogged on the orders of Senator Jeremiah Koung when they raised concerns as to why non-registered voters at that precinct accompanied by him should vote. At the moment Raymond and Rufus are undergoing serious medical attention from life threatening injuries. The part wishes to register this election malpractice.

Gblolay Precinct- District No. 5

At this precinct, supporters of Unity party, under the direct instruction and supervision of former representative candidate Augustine Menkoah, a cousin of and a lead campaign manager Senator Jeremiah Koung in Buu-Yao order the removal and subsequent beating of CDC Poll watchers from the voting precinct. This led the poll watchers to escape for their lives leaving the precinct unmanned. The subsequent effect of this action by Augustine Menkoah and his thugs lead to **massive ballot stuffing** at this precinct and the CDC wishes to register that we have no knowledge of the numbers which awarded **Unity Party 3201 and the CDC 0 votes** as placed on the record of the count being reported to NEC by that precinct supervisor and demand a rerun at said precinct. We therefore demand rerun in the entire district No. 5 as this condition was observed in several other places where poll watchers where intimidated serially during election day.

Civil Compound in Scalepea- District 7

On the orders of defeated Unity Party candidate Roger S. Domah, supporters of UP stormed the voting precinct, destroyed chairs and other facilities thereby leading to a disruption in the voting process. Again, the threat to the lives of our poll-watchers led them to flee the scene leaving Rogers and others to **massively stuff ballots** in favor of Unity party at this precinct. The CDC demands a rerun in Sacleapea as this situation was also observed in many other precincts in District no.7.

As stated above the irregularities cited at the listed precincts and districts were also observed in the following places:

- A quarantine of all votes tallied in these areas until the issues are investigated
- A complete re-run in the following districts: District 5, District 7 and District 2, District 6, District 3 and District 4
